



Registration Information 2020-21 Season



For the 2020-21 Season, Lakeshore Minor Hockey Federation (LMHF), will proceed in a two-phase registration process in context of the COVID-19 situation that prevails and inline with Hockey Quebec return to hockey guidelines which is currently in Phase 5 (See Figure 1).

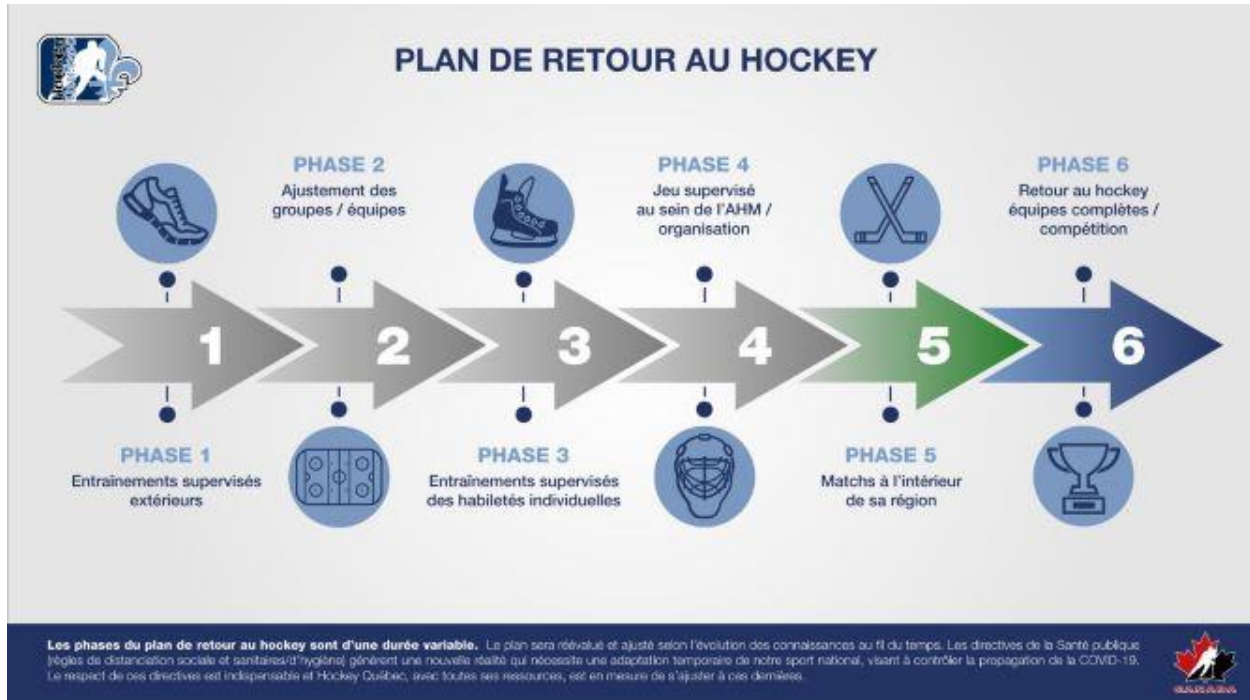

Phase 5 is a limited return to play with restrictions which consist of.

- Checking and physical contact are not allowed.
- No statistics are recorded.
- The length of the game can be adjusted depending on the associations/organizations' availability of ice times and applicable health guidelines.
- Handshaking before and after the supervised game is not allowed.

The objective of this phase is to encourage intra-region games.

This phase is also designed to prepare participants and facilitators for **Phase 6** of the plan, which consists in returning to a normal provincial competition format with full teams for which no dates have been announced for **Phase 6** as of August 2020.

LMHF is putting in place a Phase 5 and Phase 6 registration, members have the option to register for both phases or only the Phase 6 option. Regardless if a member registers for both phases or only normal return to hockey Phase 6, the final total amount for the 2020-21 hockey season will be \$525.

PHASE 5 Registration

- a. Age group U11 and under (*Atom to Pre-novice*) – **Cost \$245**
 - i. HCR Registration with Insurance coverage
 - ii. Technical on-ice clinics starting on Sept-5 or thereafter depending on ice schedule (2 Technical Staff)
 - iii. 10 sessions (*if phase 6 starts before end of 10 sessions credit will be issued for \$15 per cancelled sessions*)
 - iv. Groups of 20 maximum per sessions
 - v. Initial groups based on previous level played consideration
 - vi. Separate Goalie clinics
 - vii. Registration is complete only once a payment by cheque issued to LMHF has been received along with the signed Adherence to the ethics code by the player and risk recognition letter – **See special links section below**

- b. Age group U13 and U15 (*PeeWee and Bantam*) – **Cost \$245**
 - i. HCR Registration with Insurance coverage
 - ii. Includes Purchase of 2 personal non-branded jersey (Dark and Light Color) to be kept due to COVID-19 measures
 - iii. On-ice scrimmage with referee(s) starting on Sept-14 or thereafter depending on ice schedule
 - iv. 10 sessions (*if phase 6 starts before end of 10 sessions credit will be issued for \$10 per cancelled sessions*)
 - v. Groups of 22 (*2 teams of 10 + 1 Goalie – 5v5*) per session
 - vi. Initial groups based on previous level played consideration
 - vii. Registration is complete only once a payment by cheque issued to LMHF has been received along with the signed Adherence to the ethics code by the player and risk recognition letter – **See special links section below**

- c. Age group U18 (*Midget*) and Junior – **Cost \$245**
 - i. HCR Registration with Insurance coverage
 - ii. Includes Purchase of personal non-branded jersey to be kept due to COVID-19 measures
 - iii. On-ice scrimmage with referee(s) starting on Sept-14 for U18 and on Sept-21 for Junior or thereafter depending on ice schedule
 - iv. 10 sessions (*if phase 6 starts before end of 10 sessions credit will be issued for \$10 per cancelled sessions*)
 - v. Groups of 18 (*2 teams of 8 + 1 Goalie – 4v4*) per session
 - vi. Initial groups based on previous level played consideration
 - vii. Registration is complete only once a payment by cheque issued to LMHF has been received along with the signed Adherence to the ethics code by the player and risk recognition letter – **See special links section below**

Registration Phase 6

- A. Standard cost applies **\$525** (if registering for only phase 6) or **\$280** for Phase 6 if also registering for Phase 5 **\$245** (need to provide separate cheques for each phase)
- B. Deadline for cheque reception to be considered registered for Phase 6 is October 1st, 2020
(Cheques for **Phase 6 only** will be held by LMHF administration office until Phase 6 is confirmed and then deposited)
- C. Registration is complete only once a payment by cheque issued to LMHF has been received along with the signed Adherence to the ethics code by the player and risk recognition letter

REGISTRATION IMPORTANT NOTE:

LMHF assumes that a Phase 6 season would include the same amount of games in a potential compressed calendar as well as applicable playoffs games per the various league's rules.
